Marion County Public Schools Waiver

With your signature you accept, understand, agree, covenant and warrant the following:

Marion County Public Schools Registration Agreement & Liability Waiver:

- WARRANT TO REGISTER AND / OR TO ACT AS AGENT

For all registrants under the age of 18 or any incapable or incapacitated adult, you act as and affirm that you are the parent or legal guardian of that party/person and have complete legal authorization to enter into this agreement/waiver on their behalf and by going forward with this race/event registration, you affirm that these terms shall apply equally to all Registered Parties/Persons.

- ACCEPTANCE OF WAIVER

You understand that racing/running/walking/cycling/swimming is a potentially hazardous activity. You certify that you are physically fit and have sufficiently trained and prepared for participation in the event and have not been advised otherwise by a qualified medical professional. You agree to consent to any decision made by our race officials regarding your ability to safely complete the event. You consent to receive medical attention which may be deemed advisable in the event of an injury, accident, and/or illness during this event. You understand that all evacuation and medical costs for participants and volunteers will be borne by that person or their heirs. The race organizers and sponsors are in no way liable or responsible for medical costs or emergency evacuation.

You assume all risks associated with racing/running/walking/cycling/swimming in the event or events, including, but not limited to, weather effects, including high heat, extreme cold, high humidity, snow, ice, traffic and road conditions, slips, falls, contact with other participants, volunteers, race officials, sponsors, walkers, baby strollers, dogs on leashes, bicycles, all such risks being known and appreciated by you.

Having read this waiver and knowing these facts, and in consideration of your entry being accepted, you hereby take action on behalf of yourself, your heirs, your executors, next of kin, administrators, or anyone else who might claim on your behalf, AND HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, PROMISE NOT TO SUE AND INDEMNIFY Marion County Public Schools, its agents, servants, employees, officers, and directors from any and all rights and claims, INCLUDING CLAIMS ARISING FROM THE RELEASED PARTIES' OWN NEGLIGENCE, which you have or which may accrue to you and from any and all damages which may be sustained by you directly or indirectly in connection with, or arising out of, your participation in or association with this event, or travel to or from this event.

- Parent / Guardian Waiver for Minors (if applicable)

If you are a parent or legal guardian of a minor under the age of 18, you are representing that you are, in fact, acting in such capacity and agree to hold harmless and indemnify each and all parties referred to above from all liability, loss, cost, or damage whatsoever that may be imposed upon said parties because of any lack of capacity to act, and release said parties on behalf of the minor and the parents or legal guardian. For registration of a child under 13, you agree and



consent to the collection of that child's information, which you enter and furnish for the purposes of race/event registration.
