### WAIVER

ALL PARTICIPANTS IN THE MARFAN MAD DASH 5K WALK/RUN AND RELATED EVENTS (THE "EVENTS") ARE REQUIRED TO ASSUME ALL RISK OF PARTICIPATION IN THE EVENTS BY SIGNING THIS WAIVER, RELEASE AND CONSENT AGREEMENT: The undersigned athlete ("Athlete"), for itself and on behalf of Athlete's personal representatives, assigns, heirs, and executors, fully and forever releases from all liability, including negligence, the National Marfan Foundation, RunSignUp.com, all municipal agencies whose property or personnel are used, all other sponsoring or co-sponsoring companies or individuals related to the Events, and their respective employees, agents, volunteers, representatives and affiliates (collectively the "Releasees"). Athlete for itself and on behalf of Athlete's personal representatives, assigns, heirs and executors waives the right to sue Releasees for any and all losses and damages that arise from any injury to Athlete or Athlete's property or resulting in Athlete's death in connection with the Athlete's participation in the Events including, but not limited to, losses or damage caused by the negligence of all or any of the Releasees, the negligence of others, weather conditions or otherwise, and also including any pre-race or post-race activities and any programs and/or giveaways conducted at the events and/or activities by a sponsor or other third party. Athlete warrants that Athlete is in good physical condition and properly trained and is able to safely participate in the Events. Athlete is fully aware of the risks and hazards inherent in participating in the Events, including the possibility of serious physical trauma, injury or death arising from falls, contact with other participants, the effects of the weather, including high heat and/or humidity, traffic, and the conditions of the road, and elects to voluntarily compete in the Events knowing such risks. Athlete agrees that bicycles, skateboards, roller skates or roller blades, animals, and radio headsets are not allowed in the Events. Athlete agrees to abide by any decision of an Event official relative to any aspect of Athlete's participation in the Event, including the right of any official to deny or suspend Athlete's participation, for any reason whatsoever. Athlete agrees to the use of Athlete's name and photographs in broadcasts, motion pictures, recordings, newspapers, magazines, brochures, and other media without compensation. Athlete acknowledges that the entry fee is non-refundable and non-transferable. Athlete acknowledges that the National Marfan Foundation and its authorized agents and representatives have the right to alter, change, cancel and/or postpone any of these Events as a result of circumstances that would affect or impact the Event which are beyond their control. Athlete warrants that all statements made in this release agreement are true and correct and understands that Releasees have relied on them in allowing Athlete to participate in the Events. **ATHLETE HAS READ THE FOREGOING, UNDERSTANDS ITS CONTENTS AND INTENTIONALLY AND VOLUNTARILY CERTIFIES COMPLIANCE BY ACCEPTING THIS WAIVER, RELEASE AND CONSENT AGREEMENT.**
