COURSES: The half-marathon is a point to point course (with transportation to the start) the other races start at the church and all the races finish at the church. Flat and fast courses using both roads and the paved portions of the Wabash Cannonball Trail in Wauseon. All courses are accurately measured with mile markers and aid stations on the courses.

- Age group awards 14 & under, 15-24, 25-34, 35-44, 45-54, 55-64, 65+
- Minimum age in the Half-Marathon is 15.
- Finishers award to all Half-Marathon participants
