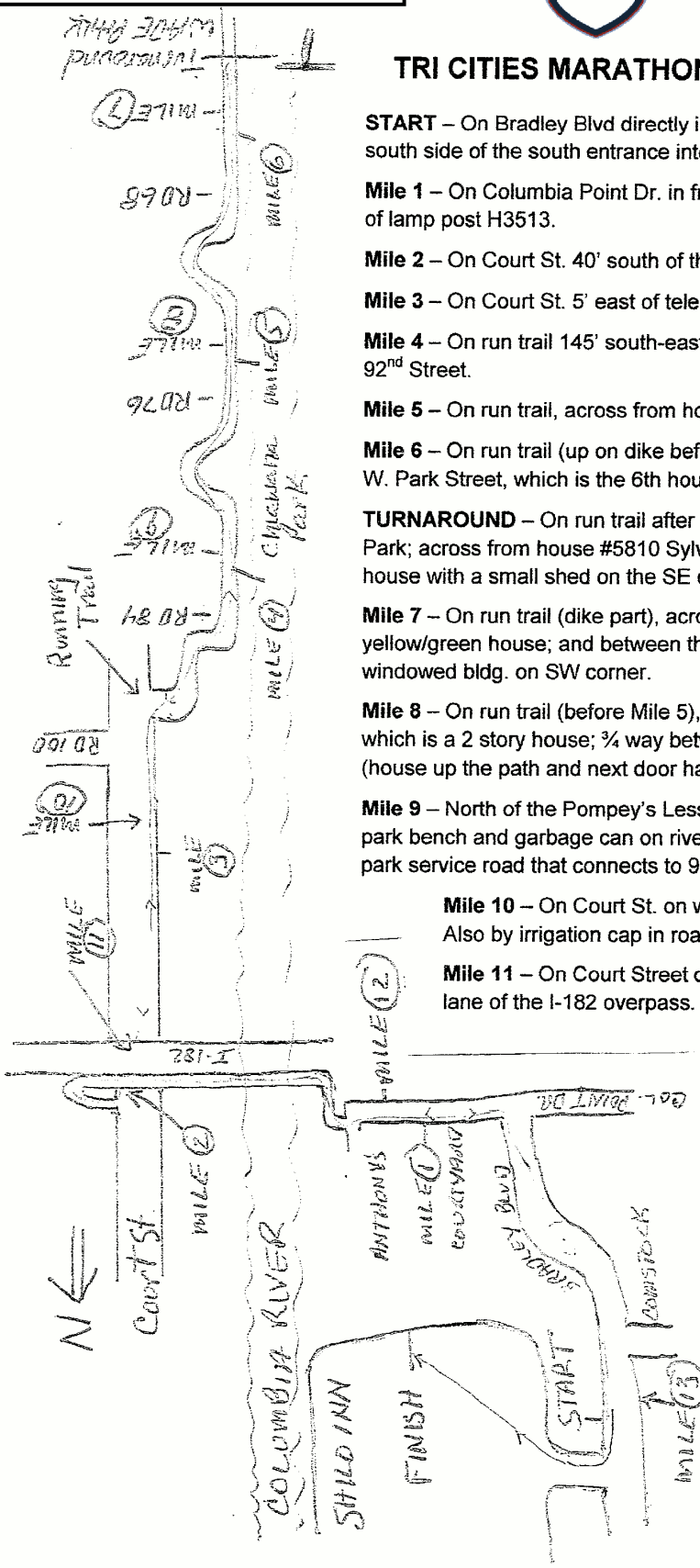




TRI CITIES MARATHON – 1/2 MARATHON COURSE



START – On Bradley Blvd directly in front of the Shilo Inn sign which is on the south side of the south entrance into the Shilo Inn parking lot.

Mile 1 – On Columbia Point Dr. in front of the Courtyard by Marriott, 21' north of lamp post H3513.

Mile 2 – On Court St. 40' south of the 'Lane Ends' sign under I-182 overpass.

Mile 3 – On Court St. 5' east of telephone pole 4945 in front of house #10204.

Mile 4 – On run trail 145' south-east of the park service road that connects to 92nd Street.

Mile 5 – On run trail, across from house #1200 N. Road 80 with a pool.

Mile 6 – On run trail (up on dike before Wade Park), across from house #6520 W. Park Street, which is the 6th house after Road 68 intersection.

TURNAROUND – On run trail after Road 60 intersection and before Wade Park; across from house #5810 Sylvester Street which is a greenish colored house with a small shed on the SE corner of the lot.

Mile 7 – On run trail (dike part), across from house #6518 Park St. which is a yellow/green house; and between the small shed on SE corner and the big 4 windowed bldg. on SW corner.

Mile 8 – On run trail (before Mile 5), across from house #7916 Sunset Lane which is a 2 story house; ¾ way between last two fence pillars on south corner (house up the path and next door has a pool slide SE corner).

Mile 9 – North of the Pompey's Lesson marker about the American Coot. Near park bench and garbage can on river side of path which is 120' upriver of the park service road that connects to 92nd St.

Mile 10 – On Court St. on west corner of house #10124 and #10204. Also by irrigation cap in road that is surrounded in cement.

Mile 11 – On Court Street directly under the middle of the southern lane of the I-182 overpass.

Mile 12 – On Columbia Point Drive between Courtyard and Anthony's. 27' south of the northern most entrance (between the two trees) to Anthony's restaurant. Also 78' south of lamp pole H3513.

Mile 13 – On Bradley Blvd, south of Shilo Inn parking lot at lamp post H3533.

FINISH – In the Shilo Inn south parking lot, 3'-6" before the metal hatch cover #8470 East end.
