Accident Waiver and Release of Liability

I, the undersigned, hereby acknowledge and understand that the athletic event commonly known as the Peak Run Against Hunger held on Saturday, May 16, 2015, at Peak Sports Club in the City of Loves Park, Winnebago County, Illinois (the "Event"), is an extreme test of individual physical and mental limits and carries with it certain risks including, but not limited to, death, serious injury and property loss, caused by such things as nutrition, hydration, terrain, facilities, weather conditions, equipment, vehicular traffic, actions of other people such as participants, volunteers, spectators, coaches, officials, and/or organizers of this Event. I acknowledge that these risks are inherent in athletic events of this type. I hereby assume all of the risks of participating and/or volunteering in this Event. I realize that liability may arise from negligence or carelessness on the part of the persons or entities being released hereby and/or from dangerous or defective equipment or property owned, maintained or controlled by them. I certify that I am physically fit and prepared to participate in this Event and have not been advised otherwise by qualified medical personnel. I acknowledge that this Accident Waiver and Release of Liability form will be used by the event holders, sponsors and organizers of the Event and that it will govern my actions and responsibilities at the Event. In consideration of my application and allowing me to participate in the event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

I expressly and voluntarily Waive, Release and Discharge from any and all liability for my death, disability, personal injury, property damage, and/or property theft, the following entities and/or persons: Winnebago County, City of Loves Park, Peak Fitness, Inc. (d/b/a Peak Sports Club), Peak Real Estate, LLC, Banz Real Estate, LLC, Rockford Road Runners, the Rock River Valley Pantry, the Event organizers, directors, sponsors, volunteers, and any and all equity-holders, officers, directors, employees, volunteers and agents of the foregoing entities/organizations (collectively, the "Released Parties"). Further, I expressly and voluntarily Indemnify and Hold Harmless the Released Parties from any and all liabilities or claims made as a result of participation in the event, whether resulting from one's negligence or otherwise.
