

The Robin 5K & Raven 10K 2017



Release, Waiver of Liability and Indemnity Agreement

<u>EVENT DESCRIPTION</u>: The Robin 5K & Raven 10K are 5 and 10 kilometer off-road trail running events to be held at 10:00 a.m. on Sunday, October 1st at Raven Run Nature Sanctuary, 3885 Raven Run Way, Lexington, KY 40515

IN CONSIDERATION OF THE SERVICES PROVIDED BY THOSE ORGANIZING THE ROBIN 5K/RAVEN 10K THE UNDERSIGNED PARENT OR GUARDIAN GIVES PERMISSION FOR THE PARTICIPANT TO ASSUME THE RISK OF PARTICIPATING AND ACKNOWLEDGES, UNDERSTANDS AND AGREES AS FOLLOWS:

- That they have the right to sign the release on behalf of the participant.
- The Robin 5K/ Raven 10K involves running on hiking trails in a nature sanctuary which may include risks such as, but not limited to, slips, trips, falls, interactions with other participants, wildlife and vegetation, the effects of weather, traffic and conditions of the road and trail.
- Participating in the race, as with any athletic event, entails risks of personal and/or bodily injuries and/or property damage, including without limitation exhaustion, sprains, fractures, or in extreme cases death.
- Warrant that the Participant is fit and able to participate in the Robin 5K/Raven 10K and assumes full responsibility for any such injuries and/or damage and medical expenses that may result.
- Acknowledges that additional or heightened risks of injuries or damage may be present because of the Robin 5K/ Raven 10K's route through the varied terrain. By way of example only, the terrain may contain naturally occurring uneven surfaces and obstructions such as ruts, rocks, roots, mud, standing water, or debris. Participant acknowledges these additional risks and assumes full responsibility for any personal and/or bodily injuries or property damage and medical expenses that may result.
- Parent/Guardian, for himself and for the Participant, his heirs, next-of-kin and successors, agrees to indemnify, defend and hold harmless the Lexington-Fayette Urban County Government, its staff and volunteers, Raven Run Citizen Advisory Board and its members, Friends of Raven Run and its members, Sponsors and Donors, for all claims and liabilities of whatever nature directly or indirectly arising out of, caused by, or attributable to participating in the Robin 5K/ Raven 10K.
- Parent/Guardian, for himself and for the participant, hereby consents to having his or her photograph taken, and grants the Lexington-Fayette Urban County Government the right to reproduce and use any photographs taken of him or her at the Robin 5K/ Raven 10K for any legal purpose, including advertisement and marketing.
- The Robin 5K/ Raven 10K will be run rain or shine, but in the event of extreme weather conditions the event may be cancelled without refund.
