PLEASE READ AND SIGN THE PARTICIPATION WAIVER BELOW

Please read carefully this acknowledgement, waiver, and release from liability (AWRL) before registering. **I hereby take the following action for myself, my executors, administrators, heirs, next of kin, successors and assigns, or anyone else who might claim or sue on my behalf, and I expressly acknowledge that it is my intent to take actions:**

1. I agree to abide by the competitive rules adopted by "Stop the Traffic".
2. I agree that prior to participating in an event, I will inspect the racecourse, facilities, equipment, and areas to be used and if I believe any to be unsafe I will advise the person supervising the event, activity, facility, or area.
3. I acknowledge that there will be emergency traffic on the course route, and I assume the risks of running and participating in this event.
4. I understand that participating in "Stop The Traffic" is a potentially hazardous activity where powdered color will be thrown at and around me during the course of the event.
5. I certify that I am physically fit for this race. I agree not to participate unless I am medically and physically able, which I am solely responsible to determine.
6. I agree to abide by any decision of a race official relative to my ability to safely complete the race, which decision is at the sole discretion of the race official, and I agree lack of a decision does not create any liability whatsoever.
7. I assume all risks associated with competing in "Stop The Traffic", including, but not limited to, slips, falls, contact with other participants, negligent or wanton acts of other participants, any defects or condition of premises, or color zones, the effects of the weather including high heat, cold temperatures, storms and/or humidity. All such risks being known assumed and appreciated by me.
8. I agree to release: elected and appointed officials, employees, all of their volunteers, servants, guests and invitees along with sponsors etc. for any and all claims, losses, damages, injuries, including reasonable attorney's fees, arising out of my participation.
9. I consent to emergency medical care and transportation in order to obtain treatment in the event of injury to me or my minor child as medical professionals may deem appropriate. This assumption and Release extends to any liability arising out of, or in any way connected with, the medical treatment and transportation provided in the event of an emergency.
10. I grant permission to release elected and appointed officials, all of their agents assisting with the event, their representatives, employees, its affiliates and sponsors to use any photographs, motion pictures, recordings or any other record of this event for any purpose including, but not limited to, promoting, advertising and marketing purposes.
11. I understand that all entries are final with no refunds.
12. The official race directors reserve the right in any event of emergency or local or national disaster to cancel the race and in the event of cancellation or change there is no refund of entry fees.
13. Participants are expected to exhibit appropriate behavior at all times, including obeying all laws. This includes respect for all people, equipment and facilities and cooperative, positive participation.
14. I understand that some of the course may go through water, colored corn starch or muds, which have not been tested for chemicals or disease.
15. I assume risk of wild animals and insects that may be present on the course.
16. Finally, I agree not to sue any of the persons or entities mentioned below for any claims, losses, or liabilities that I have waived, released, or discharged.
17. I understand that I may only participate in this event if I have brought the signed registration and waiver form along with me.

In consideration of you accepting this entry, I, the participant, intending to be legally bound and hereby waive or release any and all right and claims for damages or injuries that I may have against any elected and appointed officials, employees, agents, volunteers, servants, guests and invitees along with sponsors etc. for any and all claims, losses, damages, injuries, including reasonable attorney's fees, arising out of my participation. This release includes all injuries and/or damages suffered by me before, during or after the event. I recognize, intend and understand that this release is binding on my heirs, executors, administrators, or assignees. I also authorize the use of photographs or videos that include my image for promotional, informational, or other reasons deemed to be in the best interest of the event. I agree that I am solely responsible for determining if I am physically fit and/or skilled for the race or activities contemplated by this Assumption and Release. It is always advisable, especially if the participant is pregnant or disabled in any way or recently suffered an illness, injury or impairment, to consult a physician before undertaking any physical activity. I, for myself and my heirs, do hereby fully release and forever discharge the Administrators from any and all claims for injuries, including death or incapacity, illnesses, damages, expenses or loss that I may suffer arising out of, connected with, or in any way associated with the race, program or activities including injuries caused or associated with transportation to and from the

event. I have read and fully understand the important information, warning of risk, assumption of risk and waiver and release of all claims. If I am signing on behalf of my child or ward, I agree that I shall indemnify and forever hold the Board, its officers, employees, administrators, and/or agents harmless from any and all claims and actions that may at any time be made or instituted against them by my child or ward, or anyone acting on my child or ward's behalf, for the purposes of enforcing a claim for damages resulting from or relating to my child or ward's participation in this event. When registering online, my online signature shall substitute for and have the same legal effect as an original form signature. **Parental signatures of children on page 1 indicate that parents/guardians have read and understood this acknowledgement, waiver, and release from liability (AWRL) form. PARTICIPATION WILL BE DENIED without this waiver before the start of the event.**
