Sign-Up During Registration:

Rules for Team Fundraising

For our 20th Annual Thin Mint Sprint, we will continue to offer individuals and troops the option to fundraise to earn a portion of the proceeds for troops. Proceeds are determined by individual accounts, whether fundraising as an individual or part of a Troop Team.

*Only GSNI Troops are eligible for this option. Proceeds may only be deposited into a verified GSNI Troop bank account.

How troop proceeds are determined:

If the individual **HAS NOT** selected to earn a registration refund:

Troops receive 50% of the total fundraised by the individual. Proceeds will be direct deposited into their troop account; individuals do not receive a check.

If the individual **HAS** selected to **earn a registration refund**:

For the first \$200 donated, \$100 will go to Thin Mint Sprint proceeds, \$35 goes to pay the registration fee, and the remaining \$65 goes to the his/her selected Troop Team. Troops receive 50% of any proceeds raised over the initial \$200 individual fundraising goal. Proceeds will be direct deposited into their troop account; individuals do not receive a check. **Example of distribution of proceeds:**
