### Acknowledgment and Assumption of Risk

I understand that the disc golf course at Columbia County Sports (CCS) (the "Course") is provided for recreational use and is not actively supervised or monitored. I acknowledge that participating in disc golf activities (the "Activities") involves known and unknown risks, including but not limited to risks related to physical exertion, injury, death, damage to property or equipment, wildlife or plant encounters, weather-related hazards, and hazardous terrain (collectively, the "Risks"). I acknowledge that I am voluntarily participating in the Activities, and I accept all Risks associated with the Activities. I assume full responsibility for any injury, damage, or loss that I or anyone under my supervision sustains or causes while on the Course or participating in the Activities.

# **Golf Cart Use Agreement**

If I use a golf cart during the Activities, I acknowledge and agree to the following:

- 1. **Responsibility for Operation:** If I drive the golf cart: (1) I am solely responsible for becoming familiar with the use and operation of the golf cart; (2)I will not operate the golf cart under the influence of drugs or alcohol; and (3) I will always operate the golf cart in a safe and courteous manner.
- 2. **Age and License Requirement:** If I drive the golf cart, I acknowledge that I am at least 16 years old and hold a valid driver's license.
- 3. **Assumption of Risk:** I acknowledge that operating or riding in a golf cart involves known and unknown risks, including but not limited to risks related to physical injury, death, damage to property or equipment, wildlife or plant encounters, weather-related hazards, and hazardous terrain. I assume full responsibility for any injury, death damage to property or equipment, or loss that I, anyone under my supervision, or any passenger sustains or causes in connection with the use of the golf cart.
- 4. **Safety Guidelines:** I will follow all golf cart safety rules, guidelines, and instructions provided by CCS staff. This includes adhering to speed limits, avoiding rough or hazardous terrain, and ensuring that all passengers are safely seated while the golf cart is in motion.

# Waiver of Liability and Indemnification

I hereby release, waive, discharge, and hold harmless Columbia County Sports LLC, Columbia County Sports Foundation, and each of their members, managers, directors, officers, employees, contractors, agents, representatives, volunteers, sponsors, affiliates, and landowners (collectively, the "Released Parties") from any and all liability, claims, demands, or causes of action, whether known or unknown and whether at law or in equity, that may arise from my or anyone under my supervision's participation in the Activities, access to the Course, or use of the golf cart, including but not limited to physical injury, property damage, loss, or death. I agree to indemnify the Released Parties from any and all liability, claims, demands, causes of actions, damages, costs, or expenses, including attorneys' fees and costs, that may arise from my or anyone under my supervision's participation in the Activities, access to the Course, or use of the golf cart.

#### Medical Treatment Authorization

In the event of an emergency, I authorize CCS representatives to obtain medical treatment for me or anyone under my supervision, in CCS' sole discretion. I understand I am responsible for any medical expenses incurred by me or anyone under my supervision as a result of any injury or illness.

# **Photography and Media Release**

I grant Columbia County Sports permission to use photographs or video recordings taken during the Activities or while on the Course for promotional purposes, including on websites, social media, and marketing materials, with no compensation.

### **Acknowledgment of Rules**

I agree to abide by all rules, guidelines, and instructions provided by CCS staff. Failure to comply may result in my removal from the Course without refund or recourse.

#### Severability

If any provision of this liability waiver is found to be unenforceable in any respect, the enforceability of the remaining provisions will not be impaired.

# **Participant Agreement**

By signing below, I confirm that I have read and fully understand this liability waiver, including the golf cart use agreement, and I agree to be bound by its terms. I also affirm that I am of legal age (18 or older) or have obtained parental/guardian consent if under 18. I also understand that this liability waiver will be binding upon my heirs, executors, personal representatives, successors, and permitted assigns.

### **Governing Law and Jurisdiction**

This liability waiver is governed by the laws of the State of Oregon and any action, suit, or proceeding will be litigated in courts located in Columbia County, Oregon.
