DIRECTIONS: Find Chalmette (Judge Perez at Paris Rd.). Travel east (scenic route) on Judge Perez Dr.(Hwy 39) about 7 ½ miles. Turn left at the intersection of East Judge Perez Drive (Hwy. 46) and the Judge Perez extension road The staging area is .6 miles east on this road. Or 29° 52' 21.5" North 89° 51' 35.58" West. Or Near 1332 Hwy 46 St. Bernard, Louisiana.

AWARDS: Custom made awards by **Mike Minturn** will be awarded to the 1st, 2nd, and 3rd place overall finishers, to the 1st Masters (40 and over), Grandmasters (50 and over) and Legends (60 and over) male and female. OLD ADVISORIES: Drafting is not allowed. The course will be monitored. Since we are not USA Triathlon, we make our own rules. You get one warning without penalty. If you get a 2nd infraction, you're D.Q.ed. - Helmets are required - Competitors and race workers only are allowed in the transition area. - Race numbers must be worn and visible throughout the race. **Drafting is still not allowed.** - Radio headsets, earphones or anything that interferes with normal hearing is not allowed. Relay teams may participate but are not eligible for awards and do not receive finish tags. Please inform the finish line crew of your relay status. **Drafting is still not allowed.**

ADVISORIE: The sheriff has restricted the area we can race in because the state cut Bayou Road again. We must resort to the old "J" bike course. It is important that you **stay to your far right on the bike** especially in the 3 U-turns. You'll appreciate this if it's windy and it's better than two loops. You may or may not appreciate the 4 hills.
