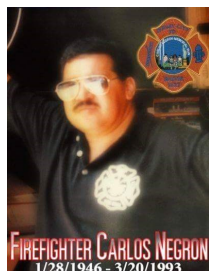

# CARLOS NEGRON MEMORIAL RUN



Carlos Negrón, a life-long resident of Jersey City was in his thirteenth year as a Jersey City firefighter when he made the supreme sacrifice.

Off-duty at the time, Carlos was assisting fellow firefighters at a 3 Alarm

fire on March 20, 1993, when the ladder he was raising became charged with high voltage from a near-by cable. Carlos left behind a widow and two children, one of whom today is a member of the JC EMS family.

This race, generously supported by the corporate community, is dedicated to his memory. Proceeds support **The Burn Center at Saint Barnabas**, New Jersey's premier burn center.

## The Jessica Ryan.org Scholarship Foundation

Jessica graduated in 1999 and during her tenure was active in many clubs and sports, Student Council, Viking Saga, SADD and Yearbook Committee. She was inducted into the National Spanish Honor Society sophomore year, and selected by her classmates as 1998-1999 NAHS Home Coming Court. After graduation she worked as a Class Aide at Washington Elementary, a job she truly loved.

Friendships she formed along the way with classmates, faculty or the community will be cherished by all for eternity.
