I/We, _____, as the parent(s) and/or legal guardian(s) of the Minor specified above (the "Minor"), do hereby authorize and grant consent for the Minor to participate in _____ (5K Run, 5K Doggy Dash or 1 Mile Walk) to be held on April 8, 2017 ("the Event"), organized by Home for Good Dog Rescue, Inc. ("HFGDR"), and furthermore I/we agree to the following:

1. RELEASE, WAIVER AND HOLD HARMLESS AGREEMENT:

a. I/We understand and acknowledge the risks associated with the Event, including but not limited to bodily injury to, or death of, the Minor (as, as applicable, any dog(s) accompanying the Minor (the "Dog," where one or more is involved in the Event)) or bodily injury to, or death of, other persons caused by the Minor or the Dog, and I/we personally assume all risks in connection with the Minor's participation in the Event.

b. I/We fully and forever release HFGDR, all sponsors of the Event and their representatives, and the officers, directors, trustees, employees, associates, volunteers, agents, or assigns of each of them (the "Released Parties"), from any and all claims, demands, causes of action or lawsuits by us, the Minor, my/our family, my/our estate, the Minor's estate, my/our heirs or assigns, or the Minor's heirs or assigns, for any and all bodily or personal injuries, accidents, property or other damage, or death suffered to or by the Minor or the Dog arising directly or indirectly from the Event, regardless of whether caused or resulting in whole or in part from the acts or omissions, including negligence, of the Release Parties.

c. I/We agree to hold harmless and indemnify each of the Released Parties against any and all claims, demands, causes of action or lawsuits, for any bodily or personal injuries, accidents, property or other damage, or death of the Minor or the Dog and for any bodily or personal injuries, accidents, property or other damage, or death to other persons or animals caused in whole or in part by the Minor or the Dog, arising

directly or indirectly from the Event, regardless of whether caused or resulting in whole or in part from the acts or omissions, including negligence, of the Released Parties.

d. I/We further certify that the Minor and, if applicable, the Dog is physically fit and qualified to participate in the Event.

2. **MEDICAL ATTENTION:**

If any emergency medical treatment is needed for the Minor it will be handled by professional Emergency Personnel who will be stationed at the Event and are licensed to practice in New Jersey.

I/We jointly and severally agree to assume financial responsibility for all costs and expenses of such medical treatment and care. I/We understand that this authorization is given in advance of any such medical treatment, but is given to provide authority to, and power on the part of, the Emergency Personnel in the exercise of his or her best judgment and discretion.
