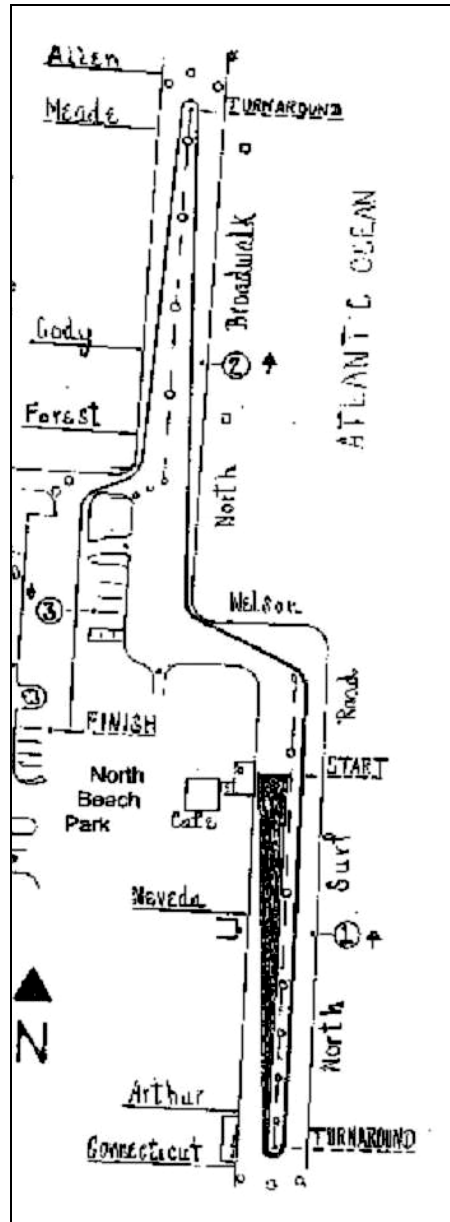


The Broward Victim's Rights Coalition (BVRC) was established in 1991 by Victim Services Professionals. The purpose of BVRC is to create awareness and empower victims by providing a comprehensive network benefitting crime victims. The Coalition provides opportunities to network with victim services providers, enhance public awareness about rights and needs of victims, encourage participation of citizens in victim service programs, serve as a source of technical support for victim related educational forums, and advocate on behalf of crime victims. 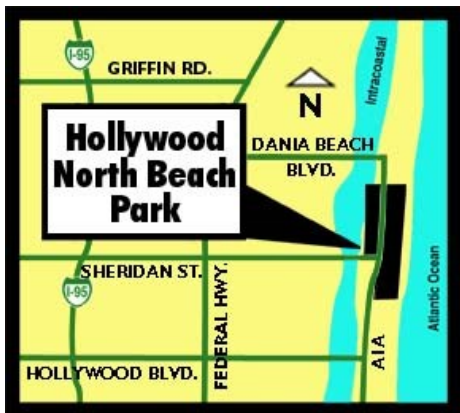
