The undersigned, for himself or herself and for his or her child, hereinafter collectively "Participants," who participate(s) in either "Minds on the Run" 5k, or "Minds on the Run" one mile walk, or both, hereinafter "the Events," and for me and my or our heirs, devisees, personal representatives, and assigns, do hereby release, acquit, discharge and indemnify Lowcountry Preparatory School and Georgetown County Public Schools, the owner or lessee of the venue of the Events, and their heirs, successors, subsidiaries and affiliates, and any and all of their members, officers, directors, agents, servants, employees, attorneys, representatives, shareholders, beneficiaries, personal representatives, brokers, sales agents, successors and assigns, the form and substance of the foregoing persons and entities collectively and hereinafter referred to as "Released Parties," from and against any and all claims, contingent claims, counterclaims, cross claims, third party claims, liabilities, demands, losses, judgments, actions, suits, causes of actions, fees, costs of litigation, indemnities, expressed and implied warranties, rights and interests, direct or derivative, known or unknown and choate or inchoate, the form and substance of the foregoing collectively hereinafter referred to as "Claims," which each of the undersigned directly or derivatively now has, or may have at any time in the future, or claims to have had now or in the future, arising out of or growing out of my or our participation in the Events.

I certify to Released Parties I am, or my child who is under 18, is or are, as the case may be, physically and mentally fit and have sufficiently trained for and am or are able to participate in the Events and, as Participants, voluntarily assume any and all risks of participation in the Events. I or we understand I or we may be photographed, filmed or videotaped at the Events, and irrevocably grant to Released Parties the absolute right and permission to use my likeness and/or voice for any purpose whatsoever, without compensation.

I or we grant my or our full permission for any first aid as may deemed to be necessary to be provided to me or my child, either during the Events on site or prior to transportation to a medical facility for medical treatment, should the need arise.

I or we understand the registration fee is a non-refundable gift to the "Minds on the Run" Events, and shall not be refundable in the event of my or our withdrawal from the Events at any time, or in the Events are cancelled for any reason.
