#### INTERSTATE-78 OR ROUTE 24 WEST

Follow signs to I-78 West. Proceed approximately 9 miles to Exit 48 (Morristown). Take Route 24 West approximately 8 miles to Exit 2A ("Morristown" Route 510 West). Once on Route 510 (Columbia Turnpike), get immediately into the left lane, go to the first light and turn left onto Park Avenue (County Road 623). Proceed on Park Avenue to the 4th traffic light and make a left into The Green at Florham Park. Use the South Entrance to the Green.

#### FROM GARDEN STATE PARKWAY NORTH

Take Garden State Parkway North to Exit 142. Follow signs for I-78 West. Take I-78 West to Route 24 West. Follow directions from Route 24 West above.

#### FROM GARDEN STATE PARKWAY SOUTH

Take Garden State Parkway South to Exit 142. Follow signs for I-78 West. Take I-78 West to Route 24 West. Follow directions from Route 24 West above.

#### FROM INTERSTATE 80 AND INTERSTATE 287 SOUTH

Follow 1-287 South to Exit 37 (NEW Route 24 East). Follow to Exit 2A ("Morristown" CR-510 West). Once on CR-510 (Columbia Turnpike), get immediately into the left lane, go to the first light and turn left onto Park Avenue (DR-623). Proceed on Park Avenue to the 4th traffic light and make a left into The Green at Florham Park.
