RESEARCH SHOWS THAT WHENEVER CHILDREN WITH AN ASSIGNED CASA VOLUNTEER RECEIVE MORE SERVICES, HAVE LESS PLACEMENT CHANGES, SPEND LESS TIME IN LONG TERM FOSTER CARE , ARE MORE LIKELY TO BECOME ADOPTED AND ARE LESS LIKELY TO RETURN TO THE CHILD WELFARE SYSTEM IN THE FUTURE.
