#### SHOW MANAGEMENT

The "LONG ISLAND HEALTH & FITNESS EXPO " is managed by Race Awesome INC. All decisions regarding space assignment, nature and style of exhibits, floor management, hours and interpretation of rules and regulations shall be made by the Race Awesome INC.

#### PAYMENT FOR SPACE

- a) Exhibitor must submit a signed agreement with a 100% payment due 7 days after signed agreement.
- b) Any space not paid in full will be made available to other exhibitors.

#### CANCELLATION

- a) If Exhibitor cancels this Agreement in writing sixty (60) days prior to the opening of the Show will receive a 50% refund.

#### SUBLETTING SPACE

- a) Subletting, assigning or apportioning of space is prohibited.
- b) Two or more firms may not exhibit in a single space, without written authorization from Race Awesome INC.

#### MOVE-IN AND MOVE-OUT INSTRUCTIONS

Specific move-in and move-out instructions will be supplied to each exhibitor and Exhibitors must adhere to these instructions, such instructions are a binding part of the contract.

#### INSURANCE

All Exhibitors and concessionaires shall, at their own expense provide and keep in force during the show period, including move-in and move-out periods, the following insurance coverage:

- a) Comprehensive general liability insurance, including blanket contractual liability, naming the Race Awesome Inc. Po Box 296, Baldwin NY, 11510. And The County of Nassau 1550 Franklin Ave, Mineola NY 11501 as an additional insured, with limits of liability with at least \$1,000,000 in respect to injuries to any one person resulting from any one occurrence, \$1,000,000 in respect to injuries to one or more persons in any one occurrence, and \$500,000 in respect to any damage of property resulting from any one occurrence.
- b) Race Awesome Inc. Po Box 296, Baldwin NY, 11510. And The County of Nassau 1550 Franklin Ave, Mineola NY 11501 shall not be responsible for any loss or damage to any property of the Exhibitor for any reason, including theft.

#### INDEMNIFICATION

Exhibitor shall indemnify, hold harmless and defend the Race Awesome Inc. Po Box 296, Baldwin NY, 11510. The County of Nassau 1550 Franklin Ave, Mineola NY 11501, their managers, Board of Directors, officers, sponsors, agents, employees, successors, and assignees. And Nassau Parks Conservancy. from all losses, claims, liability, damage, action, judgments recovered from or asserted against Exhibitor, plus expenses (including without limitation, attorney's fees and expenses) for any injury to or death of any persons, or any loss of, through theft or otherwise, or damage to property arising in anyway in connection with the use and enjoyment by the Exhibitor, or of any other persons or entity, with the permission, express or implied, of Exhibitor of the space, equipment or the show space; or arising from the use of equipment, devices furnished to or used by the exhibitor or other persons in connection with the expo, or the use of the space. Such indemnification shall not be effective if damage or injury results from the sole gross negligence or willful misconduct of the LONG ISLAND HEALTH & FITNESS EXPO or any of its employees.

#### AMENDMENTS

Race Awesome INC. shall have full power in the interpretation and enforcement of all rules contained herein, and the power to make such amendments thereto, and such further rules and regulations as it shall consider necessary for the proper conduct of a safe, clean, regulated and attractive EXPO.

#### ACCEPTANCE

It is understood and agreed that until this document is executed and returned to Race Awesome INC, it will not be deemed to be a legally binding Agreement between the Exhibitor and RaceAwesome Inc, but only an Application from the Exhibitor to the Race Awesome INC for space at the LONG ISLAND HEALTH & FITNESS. Race Awesome INC, therefore, reserves the right; in its sole discretion, to reject the Application for any reason whatsoever. If such Application is rejected, the payments received without interest will be returned to the Exhibitor within a reasonable period of time after the Application is rejected. If the The application is accepted, Race Awesome INC will execute a duplicate copy of the Application, at which time the Application shall become a legally binding Agreement between the Race Awesome INC and the Exhibitor, enforceable in accordance with its terms, and Race Awesome INC will send an executed copy of the Agreement to the Exhibitor prior to the commencement of the show. The Exhibitor understands that this Agreement is not effective or binding until accepted in writing by Race Awesome INC. Acceptance of space payments is not acceptance of the Agreement.

#### ACTS OF GOD

In case the show shall not be held due to acts of God, circumstances beyond Race Awesome INC control or any other reason whatsoever, then this permit for space to the Exhibitor shall be terminated. In such a case booth fees will be returned to the exhibitor.
