Waiver (By signing you give up certain rights): I know that running a road/trail race is potentially hazardous activity, which could cause injury or death. I/my child will not enter and participate unless medically able and properly trained, and by my signature, I certify that I am/my child is medically able to perform this event, in good health, and properly trained. I agree to abide by any decision of a race official relative to any aspect of participation in this event, including the right of any official to deny or suspend my/my child's participation for any reason. I attest that I have read the rules of the race and I/my child agree to abide by them. I assume all risks associated with participating in this event, including but not limited to: falls, contact with other participants or animals, the effects of the weather, including high heat and/or humidity, traffic and the conditions of the road/trail, including signage, damaged pavement/concrete, lips and curbs, shoulders, sidewalk transitions, steps up/down, utility access points, drainage openings, cattle grates, loose stones and gravel, ruts, erosion, tree roots and limbs, bushes and various additional hazards typical to paved/gravel/4x4 roads and trails in urban, sub-urban and rural areas, all such risks being known and appreciated by me/my child. I understand that medical aid may be delayed by distance and travel conditions and that the cost of medical care and evacuation are my responsibility. I understand that bicycles, skateboards, baby joggers, roller skates or roller blades, animals, and personal music players are not allowed in the race and I will abide by all race rules. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself/my child and anyone entitled to act on my/my child's behalf, waive and release Gold Butte Days Half-Marathon & 5k, City of Mesquite, Mesquite Chamber of Commerce, Friends of Gold Butte, Virgin Valley Artists Association, State of Nevada Department of Transportation, United States Government, its Agencies and Representatives, Authorized Right-of-Way Grantees, Mesquitos on the Run, the Road Runners Club of America and all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my/my child's participation in this event, including travel and any race related activity, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver. I warrant that all statements made herein are true and correct and understand that Releasees have relied on them in allowing me/my child to participate. I grant permission to all of the foregoing to use my photographs, motion pictures, recordings or any other record of this event for any legitimate purpose.
