**WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT IN CONSIDERATION FOR

In consideration for allowing _____ (“Runner”) to participate in the Cougar Chase 5K Run/Walk and 1K Kids Run (“Cougar Chase”), I hereby release and agree to fully and unconditionally protect, indemnify, and defend St. Louis Catholic Church and School, the Roman Catholic Diocese of Austin, and their respective officers, agents, and employees, and all promoters and sponsors of the Cougar Chase (collectively, “Indemnitees”) and hold each Indemnatee harmless from and against any and all costs, expenses, attorney’s fees, claims damages, demands, suits, judgments, losses, or liability for injuries to property, injuries to persons (including Runner) and from any other costs, expenses, attorney fees, claims, suits judgments, losses, or liabilities of any and every nature whatsoever arising in any manner, directly or indirectly, out of, in connection with, in the course of, or incidental to Runner’s participation in the Cougar Chase, **REGARDLESS OF CAUSE OR OF THE JOINT, COMPARATIVE OR CONCURRENT NEGLIGENCE OF THE INDEMNITEES.**

I understand that Indemnitees and their personnel, if attending the events, have no supervisory responsibilities in connection with the event or transportation to and from the event, but are present at the event only to answer and assist with problems should they arise. I understand that I am responsible to provide transportation to and from the event and that should any Indemnatee assist in coordinating or facilitating transportation, I hereby release Indemnitees from any liability pursuant to the preceding paragraph and understand and agree that this Waiver of Liability and Hold Harmless Agreement shall limit Indemnitees’ liability as stated above. This agreement binds Runner and Runner’s siblings, spouse, heirs, assigns, and personal representatives.
