Join us in the heart of Downtown Moultrie to help kick off Saturday events at the Spring Fling & Backyard BBQ Festival with a 10K, 5K and 1 mile Family Fun Run/Walk.

The 10K will begin in Downtown Moultrie on the square at the corner of Central Ave. & 1st Street SE. It will turn left on 1st Ave NW and left onto the Bike Trail. Runners will continue on Bike Trail until 0.08 past Mimosa Ave where they turn

around and continue back to 12th Ave. SW and turn right.

Runners will take a left on 4th St SW and a right on 7th Ave. SW.

Finally, runners turn left on 1st St. SE and continue to the Finish.

The 5K will follow the same route with the turn around at 0.16 past 12th Ave. SW. The 1 mile Fun Run follows the Bike Trail to the turn around @ 0.55 then right on 1Ave. SW and left on 1st St. SE to the Finish.

**Early Registration is \$30.00 for the 10K, \$20.00 for the 5K and \$10.00 for the 1 Mile Run/Walk. Early Registrations must be postmarked by April 1st.
(Early registrants guaranteed a free T-shirt)**

Late and race day registrations are \$35.00/\$25.00/\$15.00.

Packet Pickup from 5:00-7:00 on Friday, April 14th @ Beans & Strings on the square. Packets will also be available on-site on race day morning starting @ 7:30.

Awards will be given to the top finishers overall M/F in the 10K, 5K and top 3 winners in each age group (5 year increments) and Master finishers (50+).

Awards will be given to M/F overall winners in the Fun Run.
