

Dr. Jim and Peggie Morrow iChallenge (iChallenge) Official Rules

Presented by the Forsyth County Education Foundation, a fund of the North Georgia Community Foundation (the “Presenter”), to benefit staff scholarships for Forsyth County Schools (FCS).

1. **PROMOTION:** The Presenter is offering eligible entrants though this promotional contest the chance for prizes listed below:
 - One annual traveling trophy for the school that has the greatest median time
 - The school leader of the winning school will receive a \$150 classroom grant
 - The individual with the most minutes at the winning school will receive a \$150 gift card
 - The individual with the most minutes overall will receive a \$300 gift card
 - The first 1,700 participants receive a custom cooling headband
 - All participants will receive a certificate

To be eligible for this Contest, entrants (or their parent/legal guardian if they are a minor) must agree to these Official Rules. Entrants who are minors must have their parent’s/legal guardian’s permission to enter. By entering, entrants (or their parent/legal guardian if they are a minor) agree to comply with and be subject to these Official Rules. Odds of winning depend upon the number of eligible entrants and amount of minutes logged.

2. **ELIGIBILITY:** Open only to natural persons who are legal residents of the 50 United States and District of Columbia, who are at least 5 years of age at the time of the start of the iChallenge. The following individuals are not eligible to enter or win: FCS superintendent, members of FCS Communications and Community Engagement department, members of the Forsyth County Education Foundation board and immediate family members (spouse/partner, parent, child, sibling, grandparent, and spouse or “step” of each) and those living in the same household of each such person.
3. **CONTEST PERIOD:** Registration for the iChallenge will begin on Monday, August 28, 2023, and end on Tuesday, October 31, 2023. The fitness challenge will take place from Monday, October 2, 2023 and will end on Tuesday, October 31, 2023.
4. **REGISTRATION:** All registrations must be completely filled out and delivered to the Presenter, or an authorized representative of the Presenter prior to the end of the fitness iChallenge to be eligible to win. Entrants assume the risk of non-delivery of any entries to Presenter or an authorized representative of Presenter. All registrations entered will be provided by and shall remain the property of the Presenter. The cost of registration is \$20 for adults, and \$10 for students (18 and under only, unless student is enrolled in an FCS school).
5. **EVENT:** Once minutes are logged, they will be counted toward the entrant for the contest. No attempt to change minutes is permitted, unless deemed necessary by the Presenter. Minutes logged are on the honor system. Activity must be outside of regular activity. The iChallenge and its logo are registered trademarks of the Presenter and no

other person or entity is authorized to copy or otherwise use them without the Presenter's express written consent.

6. **NOTIFICATION:** The winners will be announced on November 15, 2023. Entrants will, where necessary, also be notified by email or telephone. Entrants need not be present to win. If the winners do not claim his or her prize from Presenter by December 31, 2023, the prizes go back to The Presenter.
7. **WINNERS:** The winners have sole responsibility for paying any and all taxes and similar fees on any prize won and must authorize the deduction of such taxes, if any, from the prize to the extent required by law. By entering, entrants release the Presenter and its members, directors, agents, employees, and other related entities from any and all liability with respect to the prize. By entering, winners consent to promotional use of their names and likeness without additional compensation. This event is subject to all federal, state, and local laws and regulations and is void where prohibited by law.
