I hereby agree to and make the following contractual representations pursuant to this Agreement: I hereby represent that I am at least eighteen (18) years of age and have full legal authority to complete this event registration on behalf of myself and/or any other party I am registering (the "Registered Parties"). If I am registering a child under the age of 18 or an incapacitated adult, I represent and warrant that I am the parent or legal guardian of that party and have the legal authority to enter into their behalf and by proceeding with this event registration and participation in the event, agree that the terms of this Agreement shall apply equally to all Registered Parties.

I represent and warrant that I am in good health; I am in proper physical condition to participate in the Event and I have not been advised otherwise by a medical practitioner. I agree that it is my sole responsibility to determine whether I am sufficiently fit and healthy enough to participate in the Event, that I am responsible for my own safety and well-being at all times and under all circumstances while at the Event site.
