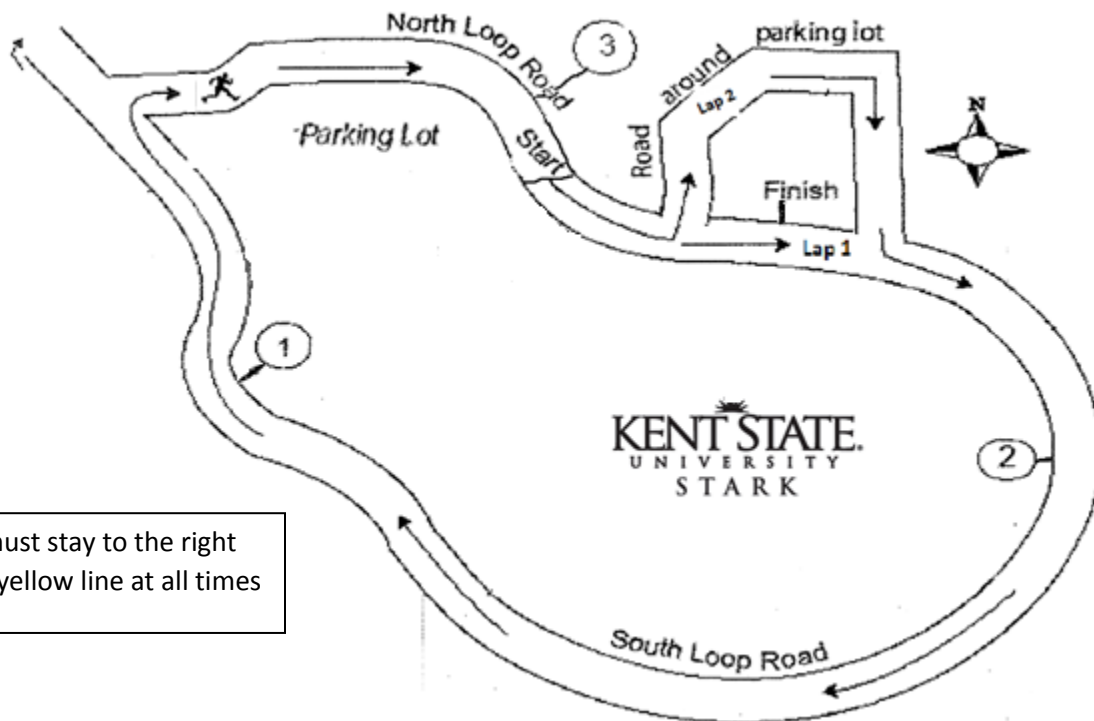
Not certified, wheel and GPS measured course

- NO EXCEPTIONS -

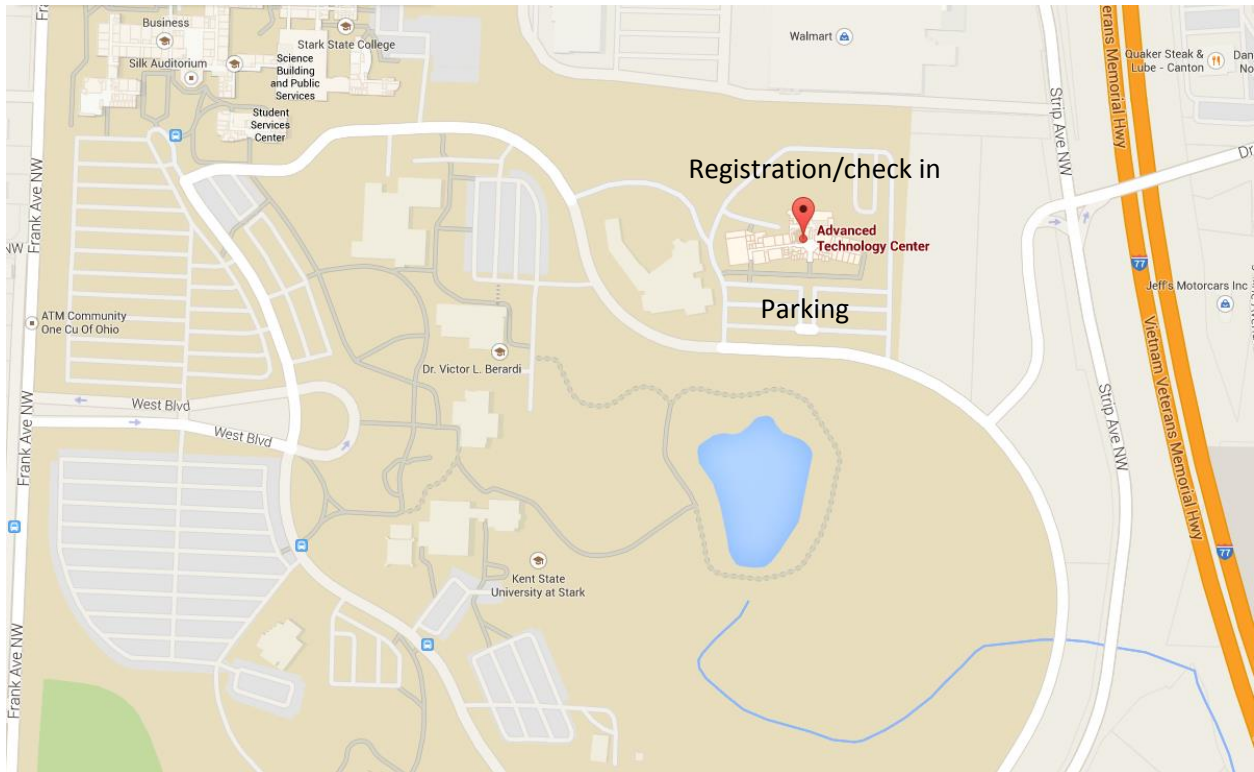
Start is at left side of front steps of Fuel Cell building on Loop Road

Finish is at sign in front of Stark State ATC building in parking lot



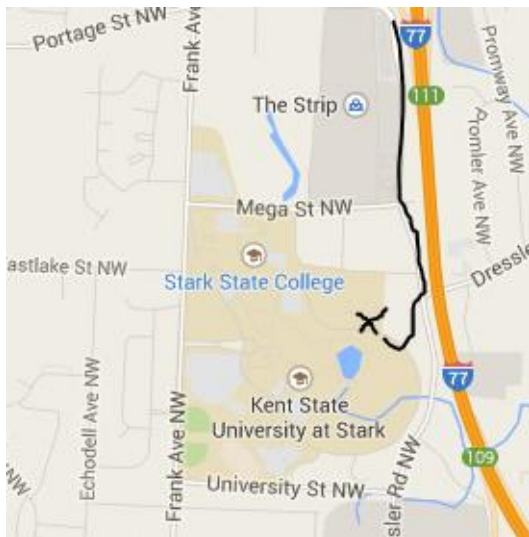
Runners must stay to the right of double yellow line at all times

Coming from North, please exit 111 on 77S, make a right onto Portage St, left onto Strip Ave (pass Walmart) and make a right in East entrance entrance of Stark State/Kent at Stark Campus (by Hall of Fame bridge).
