Race Time: 6:30 PM

Race day registration begins at 5:00 PM

Location: Purchase College, SUNY, 735 Anderson Hill Road, Purchase, NY 10577. Races start and finish in front of the Physical Education building located between parking lots East 3 and 4 and winds around a scenic loop of the campus.

Competition: Races are open to the public. Runners can compete as individuals or as part of a team, but not both. Teams are comprised of either three men, three women, or a combination of two men and two women. For each race, awards will be given to the top three men and women individual runners under 40; the top three men and women individual runners over 40; and the top men's, women's, and co-ed teams.

Registration and Entry Fee: Entry fee on race day is \$35. For those who pre-register, the entry fee is \$30 for one race and \$55 for two races, inclusive of a race series t-shirt. Runners can register and collect their t-shirt and race numbers on race day before each race up to 30 minutes before the race. Pre-registration is strongly recommended!
