WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

In consideration of acceptance of this application and myself and/or my child(ren) being allowed to participate in the Fanwood 5K Super Hero Run & Family Fun Run on Sunday, October 21st, 2018 (the "Event"), I hereby release and give up any and all claims and rights I may have against the Borough of Fanwood, USA Track & Field ("USATF"), USA Track & Field New Jersey ("USATF-NJ"), their boards, agencies and commissions, officers, agents and/or employees, officials, including elected officials, consultants or volunteers, all sponsors of the Event and any others involved in the Event on their behalf, and their heirs, successors and assigns (collectively, the "Releasees"), from and for any and all claims and causes of action, including attorneys' fees, litigation costs, and costs of suit, arising out of or relating to, any bodily injury, death and/or property damage that may be sustained by myself and/or my child(ren), whether caused by the Releasees or otherwise, in connection with the Event.

1. I am aware of the risks, known and unknown, associated with the Event. I assume full responsibility for any risk of injury, loss and/or damage, personal and/or property, whether caused by the Releasees or otherwise. I confirm that I am in physical condition to participate in the Event and I agree to abide by the guidelines established for the race by the Releasees.
2. I further agree to indemnify and save and hold harmless Releasees from any and all claims, actions, suits, damages and liabilities, including attorneys' fees it may incur relating to or arising out of my or my child's involvement in the Event, whether caused by the negligence of the Releasees, or otherwise and to reimburse the Releasees for any expenses incurred, subject to New Jersey law.
3. I grant permission to the Releasees to use any photographs, motion pictures, recordings or any other record of this Event with or without my or my child's name both single or in conjunction with other persons or objects for any and all purposes, including but not limited to public presentations, advertising, publicity and promotions.
4. This Release shall bind myself, my family, children, heirs, executors, assigns and personal representatives and be deemed as a Release, Waiver, Discharge and Covenant Not To Sue the Releasees.

I acknowledge and represent that:

- A. I have read this release, understand it, and accept it as a free act and deed;
- B. Releasees have encouraged me to consult my own attorney and I have independently determined not to engage my own counsel, recognizing the risks in doing so;
- C. No oral representation, statements or inducements, apart from the foregoing written agreement have been made;
- D. I am at least (18) years of age, fully competent and the legal guardian of the minor;
- E. I agree to this Release for full, adequate and complete consideration, i.e. permission to participate in the Event, fully intending to be bound by the same; and

I have read this release and fully understand its contents. I am aware that this Release of Liability constitutes a contract between myself and the Releasees and I sign it of my own free will.
