

Official Rules

Peak Performance Sports Camps LLC and the Weston Memorial Day Weekend Kids Fun Run Sweepstakes

- **Sponsor:** Sweepstakes Sponsor is Peak Performance Sports Camps LLC at 141 Danbury Rd, Suite 445. Wilton, CT 06897. The Weston Memorial Day Weekend 5K & Kids Fun Run Event organizers are not sponsoring this sweepstakes, nor involved in choosing the winner.
- **Eligibility:** Open only to legal residents of Connecticut age 18 or older at the time of entry. Void where prohibited.
- **Sweepstakes Period:** Began when the race website opened for registrations and ends on 8:30 a.m. ET on May 23, 2026.
- **How to Enter:** Receive one (1) entry by registering for the Weston Memorial Day Weekend Kids Fun Run event (excludes the 5K event) by 8:30 a.m. ET on May 23, 2026.
- **Alternate Method of Entry: No purchase necessary.** To enter without registering for the Weston Memorial Day Weekend Kids Fun Run event, mail your full name, street address, phone number, and email address to Peak Performance Sports Camps LLC, 141 Danbury Rd, Suite 445. Wilton, CT 06897. Mail-in entries must be received by 11:59 p.m. ET on May 23, 2026.
- **Entry Limit:** Limit one (1) entry per family, regardless of method of entry. Duplicate entries are void.
- **Prize:** One prize consisting of one (1) free week of summer camp, for one child (ages 5-14) at Peak Performance Sports Camps at their Westport or Stamford, Connecticut locations. This is subject to camp availability, session availability, and the Sponsor's camp terms and policies.
