This Agreement between the Montgomery County Road Runners Club ("MCRRC") and _____
_____ ("SPONSOR") will be effective upon signing
by both parties.

As a sponsor of the race, SPONSOR agrees to provide MCRRC, a 501(c)3 non-profit organization and member of the Road Runners Club of America, the monetary amount listed above in exchange for the services and benefits listed on page 2 of this Agreement.

Sponsorship payments can be made via credit card or check and are due prior to the date of the event.

In the event of a dispute arising between the parties, the agreement may be terminated in the following manner:

- a) If the breach is one that can be rectified, the non-breaching party may request in writing that the breach be rectified in 14 days. If the breach is not rectified within that time, the non-breaching party may terminate the Agreement immediately.
- b) If the breach is not one that can be rectified, the non-breaching party may terminate the Agreement by providing 7 days written notice of their intention to terminate.
- c) If either party goes into liquidation, is wound up, is dissolved (except for the purpose of reconstruction or amalgamation), enters a scheme of arrangement or is placed under official management or in receivership, the other party may terminate the Agreement by providing 7 days written notice of their intention to terminate.
- d) In the event of a termination of this Agreement, both parties' rights and liabilities will cease immediately but the termination shall not affect a party's rights arising out of a breach of this Agreement by the other party.

Where one party is unable to carry out its obligations under this Agreement due to circumstances beyond its control or which it could not have prevented, those obligations are suspended whilst those circumstances continue, provided the other party is notified and the first party uses its best endeavors to overcome the circumstances preventing its obligations from being carried out.

Each party shall indemnify the other party against any claims arising from any breach of the Agreement by either party.

The terms and conditions of this Agreement shall not be disclosed to any third party without the prior written consent of both parties.

The rights of either party under this Agreement shall not be transferrable or assignable either in whole or in part.
